The purpose of this position is to be a permit writer within the Agriculture Compliance Section (permitting program) of the Ground Water Quality Bureau, and will be responsible for ensuring consistency and timely agency actions regarding processing of discharge permit applications and associated tasks. This position will be responsible for reviewing discharge permit applications, drafting permits, inspecting facilities, overseeing corrective actions and abatement, preparing testimony and serving as an expert witness for the New Mexico Environment Department (NMED) regarding water quality issues related to discharge permits. Permits are administered under the New Mexico Water Quality Act and the New Mexico Ground and Surface Water Protection Regulations.
